iii) Brief Note on the implementation of CCD Plan which should cover the reasons for not achieving targets, activities which proved to be very beneficial for PTGs, activities which should be given priority, need for taking up new activities and lessons learnt etc.

The CCD plan 2007-11 has exhibited a very good result in bringing up the socio-economic status of the PTGs. But more or less in some parts the targets of the plan has not been achieved. The involvement of line department along with the micro project staff for plan formulation, implementation and evaluation is highly essential but major and most of line department staff except health are not involved in implementation and formulation of CCD Plan etc. Line Department officials need to stay at micro project area, to identify short falls through BDA, suggest and cooperate micro project during implementation of development programmes. It needs directives from respective Deptt. to their staffs to stay at Micro projects level. Coordinate meeting of District level officers with micro level based action in 4th and 5th week. Consolidated report shall be taken into need base use in our ST & SC Dev. Deptt. by which a coordinate mechanism can be developed to furnish a full fledged plan.

PART - IV

APPROACH OF THE STATE GOVERNMENT / UT ADMN. IN BRIEF FOR THE DEVELOPMENT OF PTGs DURING XIIth FIVE YEAR PLAN

1. Aim and objectives

Conservation-cum-Development Plan (CCD) started in the year 2007-08 as a Five Year Plan and due to this intervention remarkable Socio-economic upliftment has been registered in the lives of Bondas. And to further the process of development Conservation-cum-Development Plan (CCD) for the year 2012-13 to 2016-17 has been devised. The basic aim and objective of this Plan is ensure development in sustainable manner and providing the Bonda PTGs a better life style. This Plan has been prepared systematically basing on the agro climatic situation, topography, land utilization pattern by considering the basic need of the people. Under the Plan ample thrust has been given to agriculture and horticulture as income generating options by way of land development, different plantation and cultivation programmes, training and exposure visits of Bonda farmers inside and outside the state. For enhancing the adoptability and to enhance the sustainability of the people awareness programmes, SHG empowerment programmes have been designed. For Educational development running of Gyan Mandirs are ensured for pre-school going children. In addition to these human health camps, animal health camps, irrigation, infrastructure development, employability training etc are the main thrust areas of the Plan.

2. Socio-economics development:

i) Education:-

Due to various Govt. and Non Govt. initiatives the Educational status of the Bonda PTGs has risen. The student enrollment ratio is maximum and the drop out ratio has been lessened. But there is still a lot to achieve. This CCD Plan aims at 100/- enrollment of children of age group of 6-14. Under this CCD Plan there is the provision extension of running of Gyan Mandirs (Nursery schools) for 3-6 year children for their future admission in schools. There is the provision of continuation of existing Girls Educational Complex and also for construction and functioning of a new Boys Educational Complex for Bonda PTGs.

ii) Health and Nutrition:-

Under the CCD Plan there is the provision of organizing Health Camps (Quarterly) at every GP level, where medical checkup and medicines, multi-vitamins will be provided to them. Also there is the provision of reimbursement out of transportation charges and medical bill for Bonda patients getting treatment at District Headquarter or out side the District for education the PTGs about health hazards, sanitation programmes and nutrition's diet awareness programmes habeen proposed in the CCD Plan.

iii) Infrastructure:-

Infrastructural development in the form all weather access able roads, bridges, Irrigation facilities, community SHG training/Activity centers, Drinking water supply, grain banks and agricultural gowdons etc are very essential for development. It helps in improved economic activities, mobilization, more assimilation with other world and improves sustainability of the PTGs.

iv) Drinking Water and Irrigation:-

To access safe drinking water around the year, under this CCD Plan there is the provision of repair of defunct tubewells and spring based drinking water supply and also there is the provision of installation of new tubewells and sprig based drinking water supply. To ensure irrigation in maximum agricultural land, there is the proposal for construction of new WHSs, MIPs and cross bonds in addition to the repair of the existing defunct projects.

v) Income Generation:-

The main thrust area of the CCD Plan is not only to provide income generating options but also to ensure sustainability in income generation. Different horticulture and agriculture programmes like cashew and mango plantation, ginger, turmeric and yam cultivation with follow-up action has been designed to enhance the income and sustainability of the PTGs. Under the Plan the horticulture activity under plantation has been concentrated in cashew and mango plantation only with view to ensure the cluster approach of plantation where the product can further be better marketed through creation of

cooperative societies by them. There is also the provision of farmers training programmes and exposure visits to beer equip them with knowledge and experience. In addition to these, revamping the Self Help Groups by way of training prorammes, live demos and credit linkages for different activities like broom binding, khali stiching, vegetable cultivation etc. are the thrust areas of the plan.

2. Protection of traditional knowledge and Culture:

For the protection of Bonda culture and traditional, there is the provision of establishment a Bonda Museum at Mudulipada, where their culture, tradition, art and artifacts can be preserved and exhibited. There is also the provision of remodeling and beautification of 'Sitakund', which is the centre place of their tradition and worship. For better exposure of their traditional art, craft, culture and dance, there is the provision of sending the Bonda troupes to different state and district level exhibitions.

3. Institutional Mechanism:

Under the new initiative, one Anthropologist, One Junior Horticulture officer, 12 nos. of multipurpose workers have been planned to be engaged in CCD plan of 12th five year plan period (2012-2017) as part of institutional mechanism to expedite the development and conservation activities of the PTG.
