

Action points emerged from the meeting held on 23.6.2015 under the chairmanship of Secretary (TW), A&N Islands to discuss various issues related to visit of VVIP to ANTRI, formation of Curatorial team etc

A) ARRANGEMENTS FOR VVIP VISIT

- Ensuing the VVIP visit to ANTRI on 25.6.2015, following arrangements shall be made by the Director (TW)
 - a) Refreshment arrangement with the assistance of ANIIDCO Ltd
 - b) Beautification and cleanliness of ANTRI premises and building

c) Arrangement of Bouquet to the dignitaries

- d) Director (ANTRI) to arrange 06 honey containers to be presented to the dignitaries as memento
- e) Ensure uninterrupted power supply

B) MUSEUM CURATORIAL TEAM AND WORK PLAN

- The concept note on "Museum Curatorial team and work plan" prepared by Propf V. Pandya, Honorary Director was discussed and it was decided that the Honorary Director shall provide the CV of team members namely Prof Madhumita Mazumdar, Dr Manish Chandi, Shri Anirban Duttagupta & Shri Jonak.
- 2) Travelling, boarding and lodging arrangements of the Curatorial team shall be made by the Director (ANTRI) with the assistance of Director (TW).
- 3) Fixing of remuneration of the Curatorial team
- 4) First meeting of the Curatorial team will be held at Port Blair and followed with subsequent meetings at mainland.

115 HP owned by Police Department.

5) To implement the project Grain for gains submitted by Prof V Pandya, the ES, AAJVS shall submit a proposal for distribution of rice to the Jarawa tribe from the hand of Hon'ble Lt Governor, A&N Islands on 9 or 10th July, 2015 at Pottatang Anholey Chadda (Hot-spots).
