The information about sighting of Jarawas at Bornial village (Bongaon) was received at P.S. Rangat on 17/04/2013 at 1425 hrs over telephone from one Shri Tapan Mondal S/o Shri Nirmal Mondal R/o Kadamtala. On this information, a police team comprising of ASI K. Ilangovan, PC/1496 Muthu Swamy and PC/806 Jugal Dutta were directed to proceed to the spot for protection of the villagers and their properties.

The police team returned to P.S. at 2010 hrs and reported that 04 Jarawas entered into the village Bada Level (Bornial/Bongaon) which is around 07 Kms from the Bornial Jetty and around 25 Kms from P.S. Rangat. On further inquiry, it revealed that the Jarawas have taken away the house hold items like fishing net, fishing line, spade, dah, rice, sugar, edible oil, utensils etc from the house of following persons namely 1. Shri Shanti Bachar, 2. Shri Sukh Lal Bachar and 3. Shri Dulal Biswas.

The police team remained on watch and ward duty till late hours. The ward member Shri Praveen Mandol told police party that a separate report will be given to Police Station on the next day. Hence, they returned to Police Station.

Today on 18/04/13 a written report No. 1-1/GP/BT/MA/2012-13/142 dt 18/04/2013 addressed to The Secretary (Tribal Welfare) Andaman & Nicobar Administration Port Blair has been from Pradhan, Gram Panchayat Bakultala on the same issue in which names of 02 more persons Viz. Shri Cyril Indwar and Shri Kishore Biswas of the same village has also been included from whose house the Jarawas have taken away the house hold items. The above 02 persons were not present in their house on 17/04/2013 when police party reached. In her letter, the Pradhan has requested to provide utensils and livelihood support to the effected villagers of Bornial (Bongaon). The villagers are not willing to register a case but want some compensation for the loss.
