ANTI POACHING ACTIVITIES BY JARAWAS:

1. On 15.12.2005 five Jarawa boys namely Tahi, Thango, Edeya, Antowa and Mahantahe captured one Burmese from Foul bay area and handed over to Police at Louis Inlet Bay.
2. On 18.12.2005 two Jarawa girls named Thenga and Towale reached at Louis Inlet Bay and informed to Police and AAJVS staffs about the entry of large numbers of Burmese in Foul bay area. Accordingly the police and AAJVS team reached the spot and with the help of the Jarawa boys namely Tahi, Thango, Edeya, Cheo, Obeya caught 15 Burmese.
3. On 19.09.2006 three persons named Shri Suresh Bawra, Shri Ranjit Gudia and Shri Pratap Minj R/o Kadamtala apprehended from Philip Nallah with the help of Jarawas with hunting materials. Case registered under PAT Regulation Act 1956 and 3(v) ST & SC Protection of Atrocities Act 1989.
4. On 22.10.2006 15 Jarawas reached at AAJVS office Kadamtala and informed me that they have captured four Burmese and brought them at Uttara jetty by their engine dinghy. After that we along with the Jarawas handed over the poachers to Police.
5. On 21.06.2007 two Jarawas reached at JPP Camp No.11 with 4 fishermen namely Shri Sudipta Mandal, Shri Amir Hira, R/o Yeaterjig, Kadamtala and handed over to Police. The Jarawas captured the poachers from Yeaterjig creek while fishing. Case registered under PAT Regulation Act 1956.

The Jarawas further informed us that they have captured another two poachers with one wild pig and one bag of venison (deer's meat) and they kept them at Lakra Lungta area with escort of other Jarawas boys. Self along with police team reached the spot and apprehended two persons namely Shri Annadhar Mallick, Shri. Sankar Mondal R/o Yeaterjig village Kadamtala and brought at P.S. Kadamtala and case registered under PAT Regulation Act 1956 3(v) ST & SC Protection of Atrocities Act 1989.

6. On 14.07.2008 one person namely Shri Durlav Mondal S/o Shri. Mrinal Mondal 31 yrs. R/o Phooltala reached at Jarawa habitat of Dhani Nallah at around 1.00am for hunting and provided food items to Jarawas. Immediate the Jarawas captured the poachers from their habitat and few Jarawas reached at nearby JPP camp No.15 and intimated to the police. Next day morning self along with the police party reached the spot and apprehended the poachers and case registered under PAT Regulation Act 1956.
7. On 30.08.2008 five Jarawas named Titapa, Enmey, Kang, Nabuchy and Enathe reached at Uttara jetty at 8.00am with 8 fishermen with two engine dinghy and two halish dinghy and other fishing materials and informed to AAJVS staff. 3 fishermen namely Shri Y.Rama Rao S/o Yeraiah, 46 yrs, Shri. Loknathan S/o Vasu, 25yrs and Shri Somes S/o Adinarayan 25yrs R/o Baratang apprehended from Badabalu by the Jarawas at 3.00am. When the Jarawas coming to Kadamtala with the fishermen they further apprehended another 5 persons namely Shri Sukhdev Bala S/o Late Ranjan Bala age 60 yrs, Shri Ashim Roy S/o Late Atul Roy age 32yrs both R/o Santanu, Shri Amat Mondal S/o Shri Gopal Mondal age 35 yrs, Shri Sunil Mistry S/o Satyen Mistry age 30yrs, both R/o Kadamtala Shri. Raja S/o Late Seemachalan age 29 yrs R/o Uttara when fishing in Lakra Lungta.

Accordingly two cases have been registered under PAT Regulation Act 1956.

Actually the Jarawas did it because of persistent counseling that if there are any unarmed poachers capture them and inform the nearby police outpost and/or AAJVS staff, and if the poachers are armed, immediately inform to nearby police camp and/or AAJVS staff. Accordingly the Jarawas captured the unarmed poachers.
