The Meeting started with the discussion on <u>Points No. III KISAN MITRA</u> (Support to Farmers). The Joint Director (Agri) explained in detail about the marketing and infrastructural support to farmers, irrigation facilities including minor and macro irrigation for agriculture, distribution of waste land to landless and issue of Credit Card to the Framers. The Chairman desired that the awareness among the villagers/Cultivators is to be created regarding issue of credit card. Local Bank Institutions are required be recommended to provide Kisan credit card to farmers with the target to achieve the goal in agriculture sector.

Action by Jt.Dir (Agri), Mayabunder.

The Chairman asked the Medical Officer i/c, Dr. R.P. Hospital Mayabunder about the sanitary condition, epidemics, seasonal diseases and health facilities. The Medical Officer i/c, submitted that the Malaria Inspector is performing the duty of Sanitary Inspector, since no sanitary inspector has been posted in Mayabunder. Regular spray in Mayabunder Market area including fish market is being done for the prevention of water born diseases like malaria, filarial, dengu, Leptospirosis. To prevent Tuberculosis, medicine like DOTS is being given to TB patents through the trained ASHAs. Also added that, no HIV patients recorded in the area. No cases of Leptospirosis
