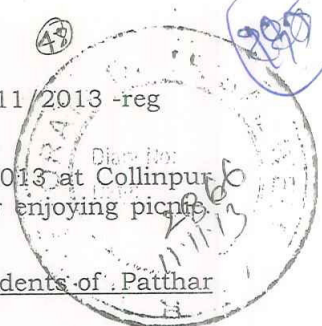

Sub : Collinpur Beach incident committed by Jarawas on 02/11/2013 -reg

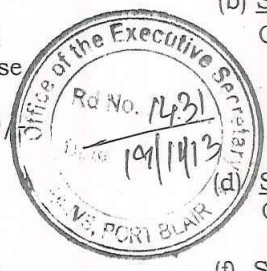
Sir,
