Sub : Repeated Death Threat by a person to AAJVS staffs – reg.

May kindly refer to

1. NCFIR filed by our Janjati Sevak namely Debrata Mondal at PS Kadamtala on 23/01/2014 U/s 507 IPC (copy enclosed)
2. A discussion in your good chamber on 15/01/2014 in presence of all Janjati Sevaks of AAJVS posted at Tirur on confession and apology in person by the accused Shri Susheel Das R/o Collinpur, S/Andaman.
3. My letter to your goodself dated 15/01/2014. (copy enclosed)
4. Letter from DGP, Port Blair to the Chief Secretary bearing DO No DGP/2014/63 dated 01/03/2014. (copy enclosed)

Sir, I am to succinctly mention about the case-history that our AAJVS team joined by Forest and Police apprehended four poachers of Collinpur and Herbertabad on 17th January 2014 in the Jarawa Reserve. One relative of one of the apprehended poachers namely Shri Susheel Das R/o Collinpur gave death threat from mobile no. 9933287791 and 9476064219 to our Janjati Sevak namely Shri Debrata Mondal on 23/01/2014. Shri Debrata Mondal filed an NCFIR at PS Kadamtala on 23/01/2014 U/s 507 IPC. Later on his apology to us in presence of the concerned DySP and your goodself we requested before you to leave the person on receipt of an undertaking from him.

Unfortunately, the above accused person by his repeated crime proved himself that he has not taken any lesson from our forgiving and showing of kindness towards him. On 27th April 2014 (Sunday) at around 0830 Hrs. our Janjati Sevak namely Sukh Bahadur while going to Collinpur beach on duty, near the bridge at Collinpur junction Shri Susheel Das called him and asked how you people of AAJVS are recruited? Further he asked in threatening manner..if I commit a murder of you with this Dao then can your AAJVS appoint me in the place you are working? It is pertinent to note that at that point of time he was carrying in his hand a sharp chopper called 'Dao' in local parlance. Shri Sukh Bahadur immediately lodged an NCFIR in PS Ograbraj (NCFIR NO. 55/14.) copy enclosed.

Sir, this is absolutely a clear and deliberate death threat causing an ironic obstruction in our duty performance. From the date of the apprehension of said poachers we are living in great fear against any predicted mishap. We request to your good self to kindly take stringent action against Shri Susheel Das and arrange for our protection preferably between Tusonabad and Tirur please.
