MINUTES OF THE MEETING OF DISTRICT LEVEL OPERATION COMMITTEE (DLOC), NORTH & MIDDLE ANDAMAN HELD IN CONNECTION WITH PROTOCOL OF SURVEILLANCE IN THE CHAMBER OF SP (D) N&M ANDAMAN, MAYABUNDER ON 27/08/2015 AT 1100 HRS.

At the outset, SP (D) N&M Andaman welcomed the participants to attend the meeting.

1. **Joint Patrolling:-** The joint patrolling by team consisting of Police, Forest and AAJVS staff are to be intensified at Middle Strait, Kadamtala, Hanspuri, Luis-in-let-Bay etc. areas. Shri. Anup Kumar Mondal, TWO, AAJVS, Kadamtala informed that the Elephants of Forest department were found roaming and damaging the huts of Jarawas. On this, SP (D) N&M Andaman advised the Forest officials to look into the matter.

2. **Display Boards:-** The display boards are to be displayed at main places by hotels/restaurant owners to ensure accurate information for tourists and to avoid illegal intrusion in the Jarawa reserved areas. The matter of installation of display board should be taken up and directions to be issued regarding guidelines in respect of Jarawa areas.

3. **Three Layer Security:-** The SP(D) N&M Andaman emphasized on three layer security for the Jarawas i.e. (1). The outer layer coastal patrolling is to be done by Indian Coast Guard and Indian Navy, (2.). The inner layer patrolling is to be done jointly by Police/PMF, Forest & AAJVS and (3). The third layer security is to be provided by joint foot patrolling.

4. **Requirement of Dug Out Bonga Dinghy:-** Shri Anup Kumar Mondal, TWO, AAJVS, Kadamtala suggested to provide dug out bonga dinghy at Middle Strait and Luis-in-let-Bay to check the activities of fishing dinghies/poachers in the Jarawa reserved areas.
