In this regard the SP/SA stated that as per Protocol of Surveillance issued vide A&N Administration's order No. 405 dated 28th November, 2014, the preventive and protective measures for the Jarawas shall include patrolling along the coast and also through land must be conducted. There shall be three layers of patrolling along the coast: the outer layer shall be formed by the Coast Guard and Navy, the middle layer by A&N Marine Police in speed boats and the inner layer by Joint (AAJVS + Police + Forest) patrolling parties in dinghies/motor boats.

Hence SP/PMF has been requested to continue the middle layer patrolling to nab the boats found in the tribal reserve water and more importantly capture the evidence in the form of videography/photography with the locational coordinates using GPS.

However, the joint patrol team comprising police, AAJVS and Forest from Tirur succeeded to detect two PAT cases ie. on 13/10/2015 and 04/11/15 by PMF FIB MV Aberdeen, in which 4+14 fishermen were apprehended with dinghies for trespassing and fishing in the Jarawa reserve area near Hiren Tikery.

- 8. As discussed during the last meeting, the Asst. Director (Fisheries) informed colour coding of the fishing boats is yet to be carried out and also no fisheries staff could be posted at Tirur. They have processed the file. Progress will be intimated.
- 9 As pointed out during the last meeting by Ms. M. Janagi Savuriyammal, T.W.O., AAJVS, Tirur, that one person namely Sujoy who was involved in contacting Jarawas earlier still visits Tirur upon which SDPO Bambooflat clarified that Sujoy whose actual name is Narayan Roy had involvement in a number of PAT cases is reportedly at Kadamtala and his activity is under surveillance.
- 10. Ms M. Janagi Savuriyammal had also suggested in the last meeting for placing a check post of Forest to check illegal transportation of wild life and sea products. In this regard Shri A.C. Tilak, ACF, F/D, South Andaman stated that their department is proposing to post a Forest Check Post with barricade at Tushnabad before link road.
- 11. Executive Secretary (AAJVS) informed that at Tirur there were 12 AAJVS field staff who are required, out of which only 10 are posted at Tirur. He also informed that they are procuring 06 motor cycles, out of which 3 will be provided at Tirur which will enhance the presence of the field staff of AAJVS in the area and also help in watch and ward over the suspicious elements disturbing the Jarawas.
- 12. SDPO/Bambooflat stated that earlier AAJVS was provided sufficient vehicles at Bambooflat, Jirkatang and Tirur for transportation of Jarawas from one place to another. The SP/SA has directed the SDPO/Bambooflat to submit a report in this regard so Director(TW) be approached to resume the services again.
- 13. SDPO/Bambooflat further stated that JPP Tirur-4 is very important and located in a strategic point from where patrolling in the sea of Tirur area is being conducted easily and if the building is provided a roof, the staff can be accommodated there. But the construction of this JPP building has been stopped without completing due to non-payment of balance amount of Rs. 15,00,000/-. The SP/SA assured that the matter will be
