At the outset all the officers were welcomed by Shri Atul Kumar Thakur, IPS, Superintendent of Police, South Andaman District and the progress made in the implementation of the Protocol of Surveillance by different stake holders was discussed.

- 1. SHO Ograbraj informed that joint patrolling from OP Tirur alongwith AAJVS and Forest is being conducted regularly in the area of Jarawa reserve, in this regard the statement submitted by him is enclosed at annexure 'A'.
- 2. SP(SA) directed SHO Ograbraj to intensify vehicle patrolling also in Tirur area covering all its villages. He has been directed to put a proposal for vehicle fitted with communication and other equipments required for patrolling. He is advised to use GPS during sea by patrolling party and do photography/videography in the event of any apprehension/recovery. He is also directed to put up proposal for procuring GPS for the patrolling.
- 3. AAJVS has been directed in the Executive Secretary(AAJVS) in the Order No. 405 dated 2811.2014 of Secretary(TW), A&N Administration to provide all safety equipments like life jackets, communication sets, and powerful lights, GPS enabled video cameras to each JPPs. In this regard EX. Secy.(AAJVS) may intimated the steps taken in this context in the next meeting.
- 4. The Ex. Secy(AAJVS) informed that for the welfare of the Jarawa tribes, a school has been started at Tirur in which around 20 Jarawa children are being educated. Rice is being served as meal. He also informed that AAJVS also doing some plantation of fruit bearing plants in Tirur for the Jarawas.
