Minutes of meeting of District Level Operation Committee (DOLC) held in the 26/2/16 chamber of SP(D)SA on 27/01/2016 at 04 PM

The meeting District Level Operation Committee(DOLC) on 'Protocol of Surveillance' in pursuance of Order No. 405 dated 28.11.2014 of Secretary(TW), A&N Administration, was held in the chamber of Superintendent of Police, South Andaman on 27/01/2016 at 4:00 PM. Following attended the meeting:

At the outset all the officers were welcomed by Shri Atul Kumar Thakur, IPS, Superintendent of Police, South Andaman District and the progress made in the implementation of the Protocol of Surveillance by different stake holders was discussed.

- 1. SDPO/Bambooflat informed that joint patrolling from OP Tirur alongwith AAJVS and Forest is being conducted regularly in the area of Jarawa reserve. In the month of January, 2016, three cases under PAT Regulations were booked in which 9 fishermen were arrested for trespassing into jarawa reserve area at Jhaukona and Hiren Tikery and seized their dinghies.
- 2. Administrative officer, AAJVS informed that the boat provided from PMF to AAJVS is still under repair and 6 motor cycles have been provided to the AAJVS field staff engaged in jarawa reserve areas.
- 3. During the last meeting the Asst. Director, Fisheries had pointed out that the jarawas and villagers/fishermen are indulging in barter system with each other. But now at village level it has been controlled but is going on in sea. In this connection SP/SA directed to counsel the fishermen not to enter into the jarawa area for fishing and not to interact and exchange any food, clothing or other articles with any Jarawa, failing which, these would be legal consequences.
- 4. As per Protocol of Surveillance issued vide A&N Administration's order No. 405 dated 28th November, 2014, the preventive and protective measures for the Jarawas shall include patrolling along the coast and also through land must be conducted.

Hence PMF should continue the middle layer patrolling to nab the boats found in the tribal reserve water and more importantly capture the evidence in the form of videography/photography with the locational coordinates using GPS.

- 5. Asst. Director (Fisheries) informed that colour coding of the fishing boats is completed.
- 6. SDPO Bambooflat informed that Narayan Roy @ Sujoy involvement in a number of PAT cases is reportedly at Kadamtala and his activity is under surveillance.
- 7. Ms. M. Janagi Savuriyammal had proposed in the previous meeting for placing a check post of Forest to check illegal transportation of wild life and are made.
