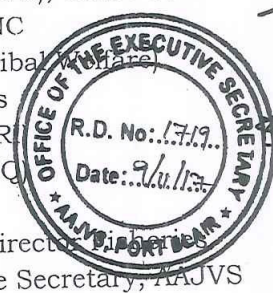
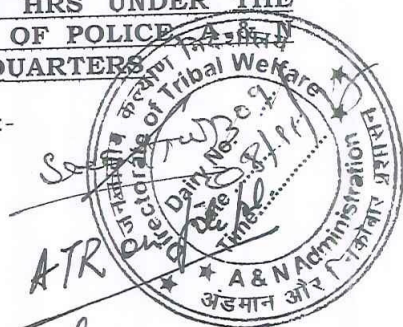

1. Repair/ Renovation work underway at Tirur No. 4 to be speeded up.

2. Augmentation of the police force posted at OP Tirur for effective patrolling duties.

3. One Boat alongwith operator for patrolling to be placed at the disposal of JPP Tirur.

4. **Protocol of circumnavigation reg:-** Regular Surveillance at Sentinel Islands & surrounding area is required. Since the area is outside the jurisdiction of PMF, hence assets of Coast Guard & ANC may be used. A schedule/request for this may be shared by Department of Tribal Welfare. **Air support for surveillance** at Sentinel Islands may be provided as per the request from Tribal Welfare department. A letter in this regard to be sent again by Tribal Welfare to ANC.

5. PS Humfrigunj to keep watch on fishermen moving out towards Sentinel Islands
