MINUTES OF THE MEETING OF DISTRICT LEVEL OPERATION COMMITTEE (DLOC), NORTH & MIDDLE ANDAMAN HELD IN THE CONFERENCE HALL OF FOREST GUEST HOUSE, BARATANG IN CONNECTION WITH PROTOCOL OF SURVEILLANCE ON 27/07/2016 (WEDNESDAY) AT 1300 HRS.

At the outset, SP (D) N&M Andaman welcomed all the participants and started the proceedings. During the meeting the following issues have been discussed and decisions were taken accordingly.

- 1. <u>Joint Patrolling:</u>- The issue of joint patrolling by team consisting of Police, Forest and AAJVS staff at Middle Strait, Kadamtala, Hanspuri, Luis-in-let-Bay etc. areas have been discussed.
 - > Shri. Bharat Maheshwari, IFS stated that he has himself gone for patrolling many times and he observed that the sound of the engine dinghy is audible from a long distance in the still & quite of forest and it is possible that the intruders may getting alert and flee away inside the jungle.
 - > On the requests made by SHO Baratang & Kadamtala, DFO Baratang assured that he will issue necessary directions to his Range Officers for providing Forest staff whenever requisitioned by the SHOs for joint patrolling. The DFO also assured to provide the assistance of Central Mobile Squad of Forest department for checking the intrusion in the Jarawa Reserve Area.
 - > Tribal Welfare Officer, Kadamtala informed that the intruders may be entering in the tribal reserve area during evening hours and returning in early morning next day particularly in Yeterjig creeks.

It has been decided that henceforth the joint patrolling shall be conducted on regular basis and all the agencies will provide manpower. It has been also decided that during Saturday, Sunday & public Holidays joint patrolling be intensified as the intruders can take advantage of non-availability of forest duty staff during the aforesaid days.
