MINUTES OF THE MEETING OF DISTRICT LEVEL OPERATION COMMITTEE (DLOC), NORTH & MIDDLE ANDAMAN HELD IN CONNECTION WITH PROTOCOL OF SURVEILLANCE IN THE CHAMBER OF SP (D) N&M ANDAMAN, MAYABUNDER ON 22/06/2016 (Wednesday) AT 1500 HRS.

The following officers participated in the meeting.

3. Shri Anup Kumar Mondal, Tribal Welfare Officer, AAJVS, Kadamtala.

At the outset, SP (D) N&M Andaman welcomed all the participants and started the proceedings. During the meeting the following issues have been discussed and decisions were taken accordingly.

1. **Joint Patrolling:-** The issue of joint patrolling by team consisting of Police, Forest and AAJVS staff at Middle Strait, Kadamtala, Hanspuri, Luis-in-let-Bay etc. areas have been discussed. Tribal Welfare Officer, Kadamtala informed that due to inclement weather they are unable to shift the available dinghy at Kadamtala to Luis-in-Let Bay. He also informed that during last one month only once joint patrolling was conducted by police and AAJVS staff but forest department did not provide any staff for joint patrolling under Kadamtala jurisdiction. SP(D)N&M Andaman stressed upon the need of increasing frequency of patrolling at least thrice in a week.

2. **Three Layer Security:** - The issue of three layer security for the Jarawas i.e. (1). The outer layer coastal patrolling is to be done by Indian Coast Guard and Indian Navy, (2.). The inner layer patrolling is to be done jointly by Police/PMF, Forest & AAJVS and (3). The third layer security is to be provided by joint foot patrolling have been discussed and it has been decided that staff will be provided by all the concerned departments for conducting joint foot patrolling for which SHOs Mayabunder, Rangat, Kadamtala, & Baratang should liaise with the HODs of Forest & AAJVS to get the names of staff for joint patrolling and ensure that joint patrolling should be carried out in the Jarawa Reserved Area thrice in a week. Tribal Welfare Officer informed that at present they are having only one camera and the same will also be provided to joint patrolling team of Baratang. Further it has been decided to
