3. **Profile of Fishermen:** - The issue of maintaining the details of fishermen of N&M Andaman District along with their photographs to identify the intruders easily by showing the photographs to Jarawas has been discussed. A joint exercise by Forest, AAJVS, Fisheries & Police has carried out at Kadamtala from 30/05/2016 to 01/06/2016 at Fish Landing Centre, Uttara in which documents of 43 boats, dinghies & licenses of fishermen were checked and found valid. Further Asst. Director Fisheries informed that there are about 36 bonga dinghies and 71 Halish dinghies are in operation in Baratang & Kadamtala and it has been decided to organize to such exercise/camp in future to check the documents as well as to create awareness the among the fishermen community. Further it has been decided to intensify patrolling in creeks to locate the illegally made and hidden dinghies and taking necessary action the defaulters in accordance with law. Assistant Director, Fisheries informed that he will furnish the details of Fishermen Identity Cards issued by the department to this office.

SP(D)N&MA informed about the boarding of Jarawa's in the tail car in the convoys plying Middle Strait to Jirkatang mostly during the last convoy and asked Tribal Welfare Officer, Kadamtala to look into the issue and take necessary steps to stop such practice of Jarawa by deploying sufficient AAJVS staff. The Tribal Welfare Officer, Kadamtala informed that recently they have engaged DRMs for the deployment at ATR.

Tribal Welfare Officer, Kadamtala informed that recently Forest Department has provided a quarter for accommodating 04 AAJVS staff at Chainpur and they are available for joint patrolling in Luis-in-Let Bay and its nearby areas. Tribal Welfare Officer, Kadamtala also requested SP(D)N&MA to provide some staff at Luis-in-Let Bay along with AAJVS staff and SP(D)N&MA agreed. At present the guard personnel deployed for Luis-in-Let Bay are camping at OP Chainpur due to collapse of the structure in which the guard was accommodated earlier. It has been decided that joint patrolling team will move to Luis-in-Let Bay and its nearby areas and stay at Luis-in-Let Bay
