

3. **Profile of Fishermen:** - The issue of maintaining the details of fishermen of N&M Andaman District along with their photographs to identify the intruders easily by showing the photographs to Jarawas has been discussed.
(Action by: Director (Fisheries), A&N Islands, Port Blair)

Apart from above, the following issues have been discussed.

1. It has been decided that a Joint Camp by Police, Forest, Fisheries and Tribal Welfare Department will be organized from 30th May to 1st June at Kadamtala and 2nd June to 4th June at Baratang Jetty respectively in which the verification of licenses of fishing dinghies, fishing licenses will be carried out. SHO Baratang and Kadamtala should make wide publicity among the fishermen about the conduction of aforesaid camp and make necessary arrangements for organizing the camp. Director (Fisheries), DFO Baratang, DFO Rangat, and Executive Secretary (AAJVS) are requested to depute suitable representatives.
(Action by: DFO Baratang/Rangat, Director (Fisheries), A&N Islands, Port Blair, Assistant Director (Fisheries) Mayabunder, Executive Secretary (AAJVS), SHO Baratang & Kadamtala)
2. On the issue of taking back the dinghy from the Jarawas at Middle Strait, which was reportedly taken from the fishermen of Baratang, the Tribal Welfare Officer, Kadamtala informed that they conducted thorough search of the dinghy along with the Jarawas but the same was not found where reportedly the Jarawas kept it.
3. The Tribal Welfare Officer, Kadamtala requested that AAJVS staff may be allowed to stay at JPP Hanspuri whenever they visit Hanspuri as there is no arrangement for their stay. On this SP(D) N&MA assured him to issue necessary directions to SHO Mayabunder in the matter.

4. DFO Mayabunder suggested that there should be hammer mark system for depicting the registration number of fishing dinghies so that the dinghy owners could be prevented from operating more dinghies with one registration numbers.
