MINUTES OF THE MEETING OF DISTRICT LEVEL OPERATION COMMITTEE (DLOC), NORTH & MIDDLE ANDAMAN HELD IN CONNECTION WITH PROTOCOL OF SURVEILLANCE IN THE CHAMBER OF SP (D) N&M ANDAMAN MAYABUNDER ON 20/05/2016 AT 1500 HRS.

At the outset, SP (D) N&M Andaman welcomed all the participants and started the proceedings. During the meeting the following issues have been discussed and decisions were taken accordingly.

1. Joint Patrolling:- The issue of joint patrolling by team consisting of Police, Forest and AAJVS staff at Middle Strait, Kadamtala, Hanspuri, Luis-in-let-Bay etc. areas have been discussed and it has been decided to conduct joint patrolling in the aforesaid areas on alternate days. In this regard, SP(D) N&MA asked Tribal Welfare Officer, Kadamtala to furnish the list of staff of his department so that a roaster can be prepared by including the staff of respective Police Stations for intensifying patrolling. DFO Mayabunder has also been requested to take up the issue with DFO Rangat and Baratang for providing the list of staff to be deployed for joint patrolling. SP(D) N&MA stressed upon the need of conducting regular patrolling between Kadamtala-Luis-in-Let Bay, Flat Island and Bada Balu area and requested Forest Department to provide wooden Dinghies for conducting the joint patrolling in Luis-in-Let Bay and its adjoining areas as 02 wooden dinghies are available with AAJVS at Kadamtala for patrolling in Kadamtala and its adjoining areas. The Range Officer, Baratang also informed that recently they recovered 1000 to 1500 traps from Tirur Kona (Bluff Island), South Andaman.

2. Three Layer Security: - The issue of three layer security for the Jarawas i.e. (1). The outer layer coastal patrolling is to be done by Indian Coast Guard and Indian Navy, (2.). The inner layer patrolling is to be done jointly by Police/PMF, Forest & AAJVS and (3). The third layer security is to be provided by joint foot patrolling have been discussed and it has been decided that staff will be provided by all the concerned departments for conducting joint foot patrolling for which concerned SHO should liaise with the local HODs of Forest and Tribal Welfare Department to get staff and carry out necessary foot patrolling in the Jarawa area. SP(D) N&MA asked the AAJVS staff to carry a camera while conducting joint patrolling so that any violation can be captured from the spot.
