Sir/madam

I am to inform you that the joint patrolling team consist of the representative of AAJVS police and forest Department with our HDPE- 90 HP.(forest Engine dinghy has not been provided since last two- three trips) proceed to jarawa reserve area from collinpur, near AAJVS field office at 0800Hrs.On 15/11/2018.


While reaching Bada goja.(Jarawa reserve area) We found a fishing engine dinghy coming out from the creek, We stopped them on the spot near/closed to the creek at about 0915 Hrs and immidiately coordinate the GPS.reading that is Lat. 11° 44" 991 N Long.

092° 31" 942 E. It was found that the Engine dinghy bearing regn. No. MV sabitri, AN SA MO 1757 on boarded three person and about 50 kg fish in the Ice box. We ask them to show the licence for fishing in the jarawa reserve area, but they failed to show the same, when ask their name and identity card it was revealed that they are -1. Matindra Gayen S/o late Manik Chandra Gayen 52 Yr- 2. Phakir Golder S/o Late Suren Golder 46 yr and 3. Megnath Das S/o Late Shrish Chandra Das 56 yr, all are Residence of Wandoor, South Andaman. The dinghy was Cheeked by the police and forest staff on the spot and the Item seized from the dinghy was -1. ice Box 2 Nos. (One box containing above 50 kg of fish) 2. 14 Hp Kirlosker Engine fitted with dinghy 3. Solar paneel 1 Nos. 4. GPS instrument (Germin make) 1 Nos. 5. Fish finder 1 Nos. 6. Jerrycan (plastic) 5 Nos of 30 Lits. Capacity (plastic) 4 Nos. (empty) and 1 Nos. With 30 Ltrs HSD oil 7. Fishing line with hook- 4 roll 8. Jerrycan (plastic) 30 Lits. Capacity containing fresh water 9. Cooking stove 1 Nos.

They were brought to collinpur and handover to the police at about 1545 Hrs, complaint was lodged with Station House Officer, Police Station Ograbraj, for initating legal action , accordingly the FIR. Was lodged against the accuse persons vide FIR. No. - 133/18 dt. 15/11/18 U/s. 7/8 A&N.island.PAT Regulations 1956.
