I am to inform you that the joint patrolling was conducted on 14/12/2018 by Joint Patrolling team consist of the representative of AAJVS - Dr Bisweswar Das T.W.O, Debashis Mondal J/S, Mahesh Mazumder Boat man (operator) with HDPE -90 HP speed boat and Kaushik Sarkar (DRM), Helper of the team, POLICE- SI Someswar Rao i/c OP Tirur, H/c Basheer and P/C Krishna Rao of OP Tirur FOREST - M. Khalid F/G II , Shyam moorthi dinghy operator with engine dinghy. The team proceed to Jarawa reserved aera with our HDPE-90 HP (Speed Boat) and Forest dinghy from collinpur near AAJVS field office at about 1215 Hrs on 12/12/2018 and the team back to the same station after conducting patrolling at about 1510 Hrs on 13/12/2018. Whereas the forest engine dinghy reached Collinpur at about 1630 Hrs on the same day.

The team proceed to Badaballu (Jarawa reserved area) from Collinpur (near AAJVS field office) at about 1215 Hrs on 12/12/2018 with HDPE 90 HP and reached Badaballu area at about 1315 Hrs ( forest engine dinghy was followed by) VIA Bamboo Nallha , Chotagoja and Badagoja . Patrolling was also conducted in the creeks / Nallha of Badaballu from 1500 Hrs to 1520 Hrs, back to Badaballu and night halt. On 13/12/2018 morning the team visited nearby Jarawa camp where we able to found two families (consist of M 2, F 2, Mch 2, Fch 5). It is reported that two – three days ago a large group of Jarawa fellow members were moved towards Horbotala Chadda and Hireen Tikrey. We back to our camp (Badaballu) had lunch and depart from Badaballu by 1400 Hrs on (13/12/2018) to Collinpur VIA Chotagoja, Bamboo Nallha and Jhookona. While coming to Bamboo nallha we encounter with a fishing dinghy coming from outside (open sea), we asked them to stop the dinghy and subsequently our staff checked the dinghy bearing Regn. No. MV BARSHA IND. AN. SA. MO. 46 and found two persons on board, namely Govindo Biswas and Narayan Baroi, both are resident of Wondoor, South Andaman. At the time of checking no objectionable items were found in the said dinghy, however we instruct them not to venture in to the Jarawa reserved area.
