Sub: - Submission of report on joint patrolling. Reg: Sir/Madam,

I am to inform you that the joint patrolling team (consist of representative of AAJVS, Police and Forest Deptt.) conducted patrolling in the Jarawa reserve area on 22/12/2018. The team depart from collinpur (near AAJVS field office) at about 0715 Hrs. While reaching Jhookona we found a fishing dinghy attached with a small rowing dinghy near the Jarawa hut (Jhookona Jarawa reserved area). We apprehend the dinghy with three persons on the spot at about 0810 hrs G.P.S coordinate was also recorded on the spot as Lat 11'42"663 N, Lon 092'34"783 E persons on board was (1) Niranjan halder S/o Late Manohar halder 49 Yrs, (2) Kaushik roy S/o shri kartick Roy 29 yrs and (3) Sanjit Bagachi s/o Ramen Bagchi 31yrs, all are resident of collinpur. Accused person with Engine dinghy was handover to police at collinpur at about 10 am for committing offence to entering/fishing in the Jarwa reserved area without permission. Subsequently a FIR was lodged with Station House Officer (SHO) Police Station Ograbraj Vide FIR No. 150/18 dt. 22/12/2018 U/S 7/8 A & N (PAT) Reg.

<u>1956.</u> Another engine dinghy was found near Lal Balu (Jarawa reserve area) attached with a small rowing dinghy having fishing material and about 50 kg of fish. The Reg. No of the said engine dinghy AND AN SA MO 1838 MFV Paritosh. G.P.S coordinate was also recorded on the spot as Lat 11'41"933 N Lon 092'34"522 E. We took the engine dinghy with two persons in our possession at about 0830 Hrs. The people are Ashit Mondal S/o late Panchanan Mondal 36 yrs and Birbal Mondal S/o Late Narayan Mondal 46 yrs both are R/o Collinpur. They also bought to collinpur and handover to the SHO P.S. Ograbraj and lodged a FIR No. 151/18 dt. 22/12/2018 U/S 7/8 A & N (PAT) Reg. 1956 for the offence to entering /fishing in to the Jarawa reserve area.

Team again proceed to Badaballu an about 1130 Hrs and back to collinpur by 1700 Hrs after completion of patrolling on the same day. (22/12/2018) Some four – five Jarawa families were found camping in the Badabalu area.

No illegal activities were noticed in the area during patrolling. This is submitted for kind information and necessary action pls.
