Sir/Madam,

I am to inform you that the joint patrolling team consist of representative of **AAJVS** - Dr. Bisweswar Das (T.O.W), P. Anil Kumar Sr. J/S , Balram Yadav J/S ,Mahesh Mazumder Boat man (operator) with HDPE -90 HP speed boat and Kaushik Sarkar (DRM), Helper of the team, **POLICE**- SI Someswar Rao i/c OP Tirur, H/c Abdual Basheer and H/C Mongovie of JPP No 01 A, **FOREST** - M. Khalid F/G II, Shyam moorthi dinghy operator with engine dinghy and Anand (labour). The team proceed to Jarawa reserved area from Collinpur near AAJVS field at about 0845 Hrs on 31/12/2018 and back to collinpur after completion of patrolling at about 1800 Hrs on the same day.

Joint patrolling team depart from collinpur near AAJVS field office with HDPE 90 HP and Engine Dinghy at about 0845 Hrs. The Speed boat was towed by Engine dinghy from jhookona to Badagoja . We reached Badagoja by 1130 Hrs, A Small team Comprising of i/c Op and T.W.O with three members proceed to Badabalu with HDPE 90 HP keeping six members team with Forest engine dinghy at Badagoja. We depart from Badagoja by 1145 Hrs and reached BadaBalu by 1215. While reaching Badabalu, we found that four Jarawa families were camping in the old Hot spot at Badabalu , patrolling conducted in the Nallha / Creeks of Badabalu 1300 Hrs to 1330 Hrs and Halt at Badabalu . Departure from Badabalu at about 1500 Hrs with a (burn case of Jawara boy) Elangoto and his wife. We reached Badagoja by 1530 Hrs departure for collinpur from Badagoja by 1600 Hrs towing our boat HDPE 90 HP by Forest boat and we reached JPP No.04 by 1745 Hrs From where we proceed to collinpur by our speed boat and reached collinpur near AAJVS field office by 1800 Hrs where as Forest boat reached collinpur by 1830 Hrs.

No illegal activities were noticed in the area during patrolling. This is submitted for kind information pls.
