**MINUTES OF THE MEETING HELD IN THE CHAMBER OF
SUPERINTENDENT OF POLICE SOUTH ANDAMAN DISTRICT ON

At the outset all the officers were welcomed by SP(D)/SA and the progress made in the implementation of the Protocol of Surveillance by different stake holders was discussed.

1. Point No.1: The Area Tribal Welfare Officer Ms M. Janagi Savuriammal informed that Multipurpose Field team has been constituted in Tirur area which visits every Jarawa camp regularly and is collecting intelligence in a systematic manner.

It was also informed that joint patrolling was being organized by police/AAJVS. Joint patrolling staff from OP JPP Tirur along with the AAJVS staff is being conducted regularly the outcome of which is as shown below:
