Topic for poster competition:

- Size of the poster: It should be of 60 cm. X 40 cm. Size on art paper.
- Criteria for participation:

Any entries on the ozone themes from any one interested in painting on the above topic-students, retired persons, amateurs of any background, painting professionals, will be welcomed. Each work will be judged solely on its merits. The competition is open to all executing UNEP's employees.
