
Minutes of the meeting held in the chamber of Principal Chief Conservator of Forests on 17.10.2001 at 11.00 AM regarding filing of reply to Hon'ble Supreme Court of India in I.A. No.502 of 1999 in W.P.No.202 of 1995 (T.N.Godavarman Thirumalpad-vs-UOI & Others

The points raised by the applicants in the Interlocutory Application No. 502 of 1999 were discussed. Copy of the I.A. has already been supplied to the concerned departments. The departments were asked to furnish their reply to the paras concerned with their department to the Department of Environment & Forests for compilation, latest by 2.00 PM of 18.10.2001. The Department of Environment & Forests shall compile the reply and send it to Secretary (Judicial) for vetting latest by evening of 18.10.2001. It was decided that the next meeting shall be held in the chamber of Principal Chief Conservator of Forests to discuss the compiled reply of the Administration at 3.00 PM on 19.10.2001.

The representatives of the departments desired that a copy of the Affidavit filed earlier by the Administration in W.P.No.76 of 1999 (Kalpavriksh & Ors.-vs-UOI & Ors.) may be supplied to them for drafting their reply. It was agreed that the copy shall be supplied latest by evening of 17.10.2001. It was also decided that the views of the Andaman Public Works Department should be sought on matters such as construction of Andaman Trunk Road and road construction within 500 metres around tribal reserve, which have been raised by the applicants in the I.A.
