Please refer to above cited reference on the subject matter.

From the above cited references it appears that despite of regular efforts made by Divisional Forest Officer, Middle Andaman the survey and demarcation work is not progressing at the desired pace. There appears some progress in Kadamtala site of the reserve falling under the jurisdiction of Bajalungta Range but there is no progress in the area of the reserve falling under the jurisdiction of Bakultala Range.

You will appreciate the fact that the survey and demarcation work is to organize by the AAJVS and Revenue Department as was decided in the Executive Council meeting held on 12.8.2008. Therefore, it is requested that detailed time frame work for carrying out of the Survey and demarcation may be chalked out, member of the survey team may be identified and named after consultation with Divisional Forest Officer, Middle Andaman and Assistant Commissioner (s) so that the survey work can be expedited. In my view a meeting with Divisional Forest Officer, Middle Andaman and Revenue authority or telephonic conversation in this regard may help in preparation of time frame and duty chart for the work.
