Drop BBMP Move on Skywalks

July 7: The wholly arbitrary and whimsical style of functioning of the Bruhat Bengaluru Mahanagara Palike (BBMP) has surfaced once again with the Palike council approving the construction of 28 new skywalks in various parts of the city. The resolution was approved without any discussion on the pros and cons of these structures and wider consultations on the suitability of the locations where they are proposed to be built Defending this atrocious decision, city mayor G Padmavathi says that the skywalks "will be built on Develop, Build, Fund, Operate and Transfer (DBFOT) basis by the advertisement companies" and there will be no financial burden on the BBMP.

First and foremost, the existing skywalks and underpasses have proved to be an utter failure. Thanks to their poor design and execution, most pedestrians have shown reluctance to use them and prefer to cross roads, risking their lives and limbs. A recent survey by traffic experts revealed that hardly 5% of people use these skywalks during peak hours. In many instances, these monstrosities have taken up the spaces meant for pedestrians and often acted as bottlenecks for the free flow of traffic. The skywalks on Sankey Road, Seshadri Road, Residency Road, K G Road, Chalukya Circle or Old Airport Road and the underpasses near City Market, Government Polytechnic or Nrupathunga Road, K H Road have been glaring examples of terrible planning that have resulted in urban waste. The latest decision of the BBMP to hand over the construction of 28 skywalks to a handful of "advertisement companies" is indeed shocking. Even assuming that they will hire engineering expertise to build these skywalks, can they be blamed for maximising their commercial interests rather than the convenience of pedestrians? Who will pay the price for such misadventures? The mayor's admission that some of these advertisement companies have been defaulters and they will be given contracts after clearing their dues is a clear indication that this is a scandal of mammoth proportions and powerful vested interests are at work. Not long ago, K Mathai, an assistant commissioner in charge of advertisements, had unearthed a scandal in illegal hoardings and had estimated that the BBMP should be earning at least eight times its current advertisement revenue of Rs 145 crore. But Mathai was shunted out without so much as an inquiry into his report.

Considering that in the guise of putting up skywalks, the BBMP is bartering away valuable land in prime locations like M G Road boulevard, near the Nimhans, the Silk Board junction and the Cantonment railway station for private promotion, the BBMP should withdraw the decision or the state government should intervene immediately and review the decision in larger public interest.

After the release of these video, the government had banned all tourist/commercial activities within five kilometres of the reserved area inhabited by aborginal tribes like the Jarawas in the Andamans.

In 2014, there were reports of poachers

sexually exploiting Jarawa tribe women in exchange of alcohol and marijuana. Following this, an enquiry was set up by the then Lieutenant Governor of Andaman and Nicobar Islands Ajay Kumar Singh.

Writing for Firstpost in 2014, Jay Mazoomdar had noted that the crimes committed against the Jarawas and the apparent heartlessness of the authorities towards them. He had also noted local MP
