## MEMO

It has been noticed that Smti. Sriti Sarkar, Pharmacist posted at Kadamtala is not performing her duties and responsibilities as per the common order No: 01 dated 13th June, 2012 issued to all employees. Smti. Sriti Sarkar is usually leaving her duty place in between 10.30 am to 12.00 noon without any intimation to the undersigned while he is also present at field (Jarawa Reserved Area). It seems that she is intentionally not obeying the orders of her superior and insulting the undersigned. In past record of Smti Sriti Sarkar also reveals that she is a habitual to leaving her duty place within one or two hour's performance without any permission.

On 20/06/2012 Shri Bibhiti Biswas, Janjati Sevak, and Shri Som Naidu, DRM, AAJVS deployed at Camp No. 10 reported that around 1230 hrs one Jarawa woman namely Tyleho reached at Camp No. 10 adjacent to ATR from western coast with her 7 months old ailing baby for medical treatment but Smti Sriti Sarkar was not present at duty place to provide in situ treatment to the ailing baby. On 21/06/2012 morning the baby had shifted at PHC. Kadamtala by Smti Sriti Sarkar with high fever for treatment. If she was present on her duty place in-situ treatment could be provided to the ailing baby at Camp No. 10 and the baby needs not to be shifted at hospital on next day. In many occasions Janjati Sevaks have shifted serious Jarawa patients at P.H.C Kadamtala from ATR camps in afternoon/ evening hours in absence of Smti Sriti Sarkar those were treated by her at morning hours or other serious Jarawas patients came from western coast for treatment. It is also reported and observed that she is always in hurry to come back her home just pay a visit at Jarawa habitat for few minutes for treatment / handing over the medicine to Jarawas. She is irresponsible and her attitude and activities also encourage to other employees to carry out such types of practices. This seems her punctuality and dedication of her work for which she has been appointed and regularized by AAJVS.

This issue is taken very seriously and the undersigned is compelled to seek explanation in writing from Smti. Sriti Sarkar why she is leaving her duty place everyday without complete normal duty hours and without any permission of the undersigned as mentioned in order No. 01 dated 13th June, 2012. Her reply should reach the undersigned by 5<sup>th</sup> September, 2012 at 4.00 pm.
