	iv)	Augmentation of water supply: It was informed that there has been acute shortage of potable water,; at Strait Island as there was only one ring well and a RO Plant for meeting the entire requirement of water for the inhabitants of the island. It was also pointed out that the existing RO Plant was not hygienically maintained inspite of the request made to the Deputy Commissioner (North & Middle Andaman) and the Executive Engineer concerned of the area. In order to provide the basic need of potable water, it was decided that APWD through its field officers concerned shall take immediate action to ensure that the RO Plant and the Ring Well are maintained hygienically and feasibility explored for construction of a small check dam/water body for augmentation of the water supply in the area	APWD has been asked to explore possibility of construction of a check dam for supply of SAFE DRINKING WATER at Strait island.
