Sir,

With reference to your letter no: WS/9-3/CE/2010-11 dated 4<sup>th</sup> March 2011 I am to state that during the meeting of Executive Council of AAJVS held on 12<sup>th</sup> August 2010 at Raj Niwas under the Chairmanship of Hon'ble Lt. Governor, it was decided that:-

AAJVS shall convey the cancellation of construction of sea wall at Strait Island and staff quarters at Dugong Creek to APWD. APWD shall utilize these funds for construction of retaining wall at Strait Island and toe wall / retaining wall for Jarawa Ward PHC Baratang. The balance amount shall be refunded to AAJVS.

As resolved during the meeting, AAJVS has conveyed cancellation of c/o sea wall at Strait island and staff quarters at Dugong Creek. The EE, MID has refunded the unutilized amount of ₹ 42,61,837/- but the unutilized amount as decided in the Executive Council meeting of AAJVS for the cancellation work of sea wall at Strait island for ₹ 168.00 lakhs lying with the Executive Engineer, CD-I, APWD, Port Blair is yet to be refunded.

As resolved during the Executive Council meeting held on 12<sup>th</sup> August 2010 your are requested to utilize an amount of R 24,50,366/- out of R 168.00 lakhs for c/o retaining wall and toe wall for Jarawa ward at PHC Baratang Complex and retaining wall at Strait Island and refund the balance unspent amount to this Office for adjustment of the account outstanding against your department. It is to mention here that the CAG audit had mentioned serious observations on this issue in their report during Audit of AAJVS accounts

You are therefore requested to look into the matter and direct Officers concerned to implement the decision of the Executive Council meeting at the earliest.
