The proposal is for according Administrative approval & Expenditure sanction to the estimate for the work "Providing water supply for newly constructed quarters for Great Andamanese at Strait Island" at an estimated cost of Rs.7,00,403/-.

The preliminary-cum detailed estimate is prepared based DSR-2007 with cost index of 154%. A provision of 5% for contingent charges and 1% labour cess has been provided. The design and scope of work includes:

1. Providing and fixing G.I Pipe line.
(a) 20mm, 25mm, 40mm and 50mm dia nominal bore.
2. Making distribution connection.
(a) 25 to 40 and 50 to 80mm dia nominal bore.
3. Providing fun metal gate value.
(a) 25mm, 40mm and 50mm dia nominal bore
4. Providing and fixing G.I Union
(a) 20mm, 25mm, 40mm and 50mm dia nominal bore.

No specific provision of fund for this work has been provided during the year 2010-11. The MoTA, GOI shall be releasing funds under the CCD Plan for the 2011-12 as promised by Joint Secretary of the Ministry vide para 180/n. The department has proposed to take up the above work against the funds to be release by Govt. of India for utilizing developmental works at Strait Island including toe/retaining wall and water supply. Time limit prescribed for completion of the work is 01 (One) month. Principal Secretary (TW) has approved the proposal.
