



- 3) As per Daily Order Sheet No. 4 dated 19.10.2009, Shri. K. Mohd Salim, Driver S/o Shri. K. Ummer R/o Kanyapuram, Wimberlygunj was called for to appear as State Witness-3 on 12.1.11.2009 at 1000 hrs.. Shri. K. Mohd Salim has appeared before the Inquiry Officer on 12.11.2009 and given his statement in writing. As per his statement Shri. Mohd Salim has not seen any one at the residence of Smti. Jayalakshmi on 7.10.2008 between 1.00 am and 2.45am. (copy of his statement is enclosed)
- 4) As per Daily Order Sheet No. 4 dated 19.10.2009, Miss G. Karthika D/o Shri. N. Gunashekheran R/o Srinagar, Minnie Bay was called for to appear as State Witness-4 on 12.11.2009 at 1200 hrs. Miss. G. Karthika has not appeared before the Inquiry Officer on 12.11.2009.
- 5) Shri. M.A. Naushad, SHO presently posted at Rangat has appeared before the Inquiry Officer as State Witness-2 on 2.12.2009 and given his statement in writing. He identified his signature on the FIR No. FIR No. 835/08 dated 7.10.2008 U/S 342/354 IPC and on notice of arrest of a Govt. Servant vide No. PS/AB/46/08/5047 dated 8.10.2008 marked as exhibit I & II respectively.
- 6) Smti. MV Jayalakshmi, SW-1 and Miss G. Karthika, SW-4 have not appeared before the Inquiry Officer on 2.12.2009 and 15.12.2009.
- 7) Three notices were served to both Smti. MV Jayalakshmi, SW-1 and Miss G. Karthika, SW-4 to appear before the Inquiry Officer but inspite of having received and acknowledged the notices of all the three hearings they have not appeared.
- 8) As per Daily Order Sheet No. 8 dated 15.12.2009 Shri. Mohd Zakir, L.V.Driver, Directorate of Tribal Welfare and Shri. Kishen Singh, Hindi Translator, ALHW, Port Blair were called for for deposition of both the Defence Witnesses on 21.12.209 at 1000 hrs.
- 9) Shri. Mohd Zakir and Shri. Kishen Singh appeared before the Inquiry Officer as Defence-Witnesses on 21.12.2009. They were examined on 21.12.2009 and their statements were obtained. The statement given by Shri. Mohd. Zakir and a copy of page No. 42 of log book of AN -C-0425 reveals that Shri. Govind Ram was on tour to Tirur. While returning from Tirur, Shri. Govind Ram stayed at the site of his friend at School Line at about 2.00 pm and inspected the site. In the mean time a PCR van came from Minnie Bay side at about 2.45pm and called Shri. Govind Ram to come with them to Police Station, Aberdeen as there is a complaint against him. (Copy of his statement is enclosed)

The statement given by Shri. Kishen Singh reveals that Shri. Govind Ram came to his site at School Line at about 2.00 pm and inspected the site. In the mean time a PCR van came from Minnie Bay side at about 2.45pm and called Shri. Govind Ram to come with them to Police Station, Aberdeen as there is complaint against him.
