

Incident with a female Jarawa (PTG) at Tirur - Reg. Sub:

Sir,

11-31/AAJVS/2008/412 dated Kindly refer to the letter No. 29/09/2010 on the above mentioned subject. In this connection it is to inform that a case Cr. No. 192/10 dated 25/09/10 U/s 325/504 IPC r.w.s 3(1) (x) SC/ST (Prevention of Atrocities) Act 1989 has been registered at Police Station Ograbraj on the written complaint of Shri Raj Kumar Kongari S/O Late Ishak Kongari (32), Field attendant, AAJVS, Tirur No. 1 (A).

The matter was reported to the I/C OP Tirur, ASI Shiva Kumar by Shri Raj kumar Kongari , Field attendant on 25/09/2010. One police constable, PC Gupta of JPP Tirur No. 1(A) was immediately deputed with Shri Raj Kumar and Shri Anbukarasan, who went to the Jarawa settlement at Old Tirur No. 4 where they found Jarawa lady, Baliwaye present in the hut. Baliwaye, the injured lady, narrated them the entire incident stating therein that that on 24/09/2010 at 1130 hours, she alongwith 03 other Jarawa ladies, namely, Anijay, Manji and Ethaji were returning to their hut at Tirur No. 1A after fishing at Herbertabad. While they were walking on the the "Bandh" in the paddy field in Herbertabad, one Sujai of Herbertabad village abused them in filthy language. When they asked him as to why he was abusing, he threw a 'balli' towards them, due to which, she (Baliwaye) was injured on her left arm.

Thereafter, shri Raj Kumar Kongari brought the injured Jarawa lady, Baliwaye to PHC, Tusnabad for treatment. SHO Ograbraj informed the undersigned about the said incident. The undersigned immediately rushed to PHC Tushnabad and enquired the matter with the injured Jarawa lady, the AAJVS staff and the police personnel and also spoke to the doctor of PHC Tushnabad with regard to the nature of the injury.

On the written complaint of Shri Raj Kumar Kongari, worker of AAJVS, a case vide crime no 192/10 dated 25/09/10 U/s 325/504 IPC r.w.s 3(1) (x) SC/ST (Prevention of Atrocities) Act 1989 has been registered at PS Ograbraj and the undersigned took up the investigation. During the course of investigation, the accused, namely, Shri Narayan Roy @ Sujai S/O, Shri Khokan Roy (25), R/O Herbertabad has been arrested on the same day (i.e. 25/09/2010) and produced before the Hon'ble Court of CJM, Port Blair on the following day (26/09/2010) and remanded to 14 days Judicial Custody. The investigation of the case is in progress.
