STA suspends two bus owners permits

Port Blair, June 21

The State Transport Authority (STA) has suspended the stage carriage permit in respect of two owners of buses for violation of Motor Vehicle Act as also the provision of notified Jarawa Policy. According to separate communications received from the Secretary, STA, the stage carriage permit in respect of Shri H.B. Shukla of Rangat has been suspended for not plying his bus on the allotted route with normal passengers and charging excess

Similarly, the suspension of such permit has also been done in the case of Shri R.S. Yaday of Buniyadabad for violation of the notified Jarawa Policy and the do's and don't's prescribed for transiting through the Jarawa reserve areas. The bus belonging to Shri R.S. Yadav, has also been found to violated the Motor Vehicle Act 1988 for not plying the vehicle/ completing the journey in the allotted route and for charging excess fares from passengers, the communications added.
