## NOTICE

Whereas, upon directions of the Hon'ble High Court at Calcutta Circuit Bench at Port Blair for carrying out land to land survey upon the land bearing Sy. No.282 & 300/2 areas 0.88 & 0.60hects situated at Caddlegunj village under Ferrargunj Tehsil recorded in favour of Shri. Anthony Stephen S/o late Selvaraj R/o Junglighat.

Whereas, this court issued direction to the stakeholder Departments for demarcating the said land on dated 26<sup>th</sup> April 2011 at 09.30 Hrs for measuring the exact distance from the boundary of the Jarawa Tribal reserved area to the Sy. No.282 & 300/2 areas 0.88 & 0.60hects situated at Caddlegunj village under Ferrargunj Tehsil recorded in favour of Shri. Anthony Stephen S/o late Selvaraj under Ferrargunj Tehsil.

Whereas, after the Ariel joint demarcation by the stakeholder Departments, the land bearing Sy. Nos. 282 & 300/2 measuring areas 0.8800 & 0.6000 Hects situated at Caddlegunj village under Ferrargunj Tehsil classified as House site, Commercial and Hilly respectively was falling within the Eastern side of (4.32 Kms) from the Imaginary boundary line of "Jarawa Protection of Aboriginal Tribe" South Andaman District.

Whereas, now as per the Hon'ble High Court directions, your presence along with your entire team shall be present at 20<sup>th</sup> February 2012 at 09.30 Hrs at the spot to assist the Revenue Inspector Circle (3) and team of Revenue Survey for demarcating the aforesaid distance from the land bearing Sy. No.282 & 300/2 areas 0.88 & 0.60hects situated at Caddlegunj village under Ferrargunj Tehsil recorded in favour of Shri. Anthony Stephen S/o late Selvaraj under Ferrargunj Tehsil. The starting point of demarcation shall be from the recorded tenant's land.

Whereas, the above Survey is a time bound work and report compliance has to be furnished before the Hon'ble High Court.
