- 2. We have to acquire pants and shirts for men among the Jarawas as they have started depositing the small handmade honey containers. Anup Mondal from Kadamtalla has the detailed requirements. Like the basket the details of the honey containers needs to recorded and a small booklet for it's packaging needs to be made. ANTRI staff could be asked to make the booklet based on the one made for the Jarawa basket.
- 3. Please inform the position on the Coconut plantation at Dugong Creek, when will it be returned back to Ongees? Need to fix and formulate the future functioning of the plantation for and of the Ongee cooperative so that the money is back with the Ongees.
- 4. Completion of the process for paying workers in Jarawa reserve territory for the teaching class work. Please note that LG has expressed his desire to visit Potatang (as a possibility) in Mid March.
- 5. What was the position on the late night use of ATR in the vicinity of Porlobjig? This is a matter of importance and the Sect TW had asked for a report and recommendation. This is urgent given the fact that ATR is going to be further developed in near future.
- 6. Ground report from Great Nicobar pertaining to Shompens.
- 7. Final draft of the Sentinelese order.
- 8. Revision of the surveillance of the JRT in accordance of the MOTA meeting. There is a need for the orientation and the autonomy of singular body involved in the work.
- 9. Formal adoption of the vision statement provided for AAJVS.
- 10. Has the work required for immunization of children among Jarawas started?
- 11. Please organize a meeting and invite a "homework done statement" to discuss on Research Projects, Issue of Rice and new recruitments for office and research.
