

### Illegal entry of outsiders in Strait Island

Port Blair November 20.2006: The Great Andamanse was the largest tribe before the commencement of penal settlement but with the passage of time their population has decreased and as on date they are just 44 individuals. The Local administration with the help of experts has been making all out effort to save this nomadic tribe from extinction and in process they are being provided with houses, clothes and free ration. Certain areas have been reserved for them and no outsider is permitted to enter in these tribal reserves without valid permission so that this tribe can grow and develop in their natural habitat. As we all know that Strait Island is one such Island where the great andamanse have been settled and to visit this Islands one needs tribal pass but to our utter surprise, we are being informed that many outsiders visit this Island and interact with the local inhabitant without any tribal pass or permission but some also involve themselves in illegal felling of trees under the pretext of being engaged as laborer in construction work. It has been reported that one such group involved in illegal activities with the connivance of local authorities is headed by one self styled contractor namely Shri M. Velumurugan S/o Maya Alagu. He himself and his 11 no. of laborers are staying there without any valid permission and being an enlisted contractor with APWD having no work entrustedm to him in Strait Island but still he claims that he and his labour to be engaged in the construction of permanent structures for Andamanese. ... Sewalia has been convicted and sentenced to Rigorous Imprisonment for a period of three years and a fine o Rs.50,000/- for amassing assets disproportionate to his known sources of income. After a keenly contested trial the Court of Shri G.P. Mittal, Special Judge, Tis Hazari Court Delhi on Wednesday held Shri G.P. Sewalia guilty of the commission of the offences of possession of disproportionate assets and yesterday awarded the sentence to three year jail term.
