Kindly refer the radio message & the subject cited above regarding constitution of team for survey/demarcation of Jarawa Reserve areas in Middle Andaman Division. The status report is as under;

- 31-08-2007 - Office order issued from DFO MA regarding formulation of team for Survey & demarcation of Jarawa reserve area for Bajalungta range.
- 11-01-2008 - Received report on Survey & demarcation of Jarawa reserve area from Range Officer, Bajalungta.
- 28-01-2008 - Letters issued from DFO MA to the Range Officers Bakultala & Betapur to constitute a team for Survey & demarcation of Jarawa reserve area.
- 29-01-2008 - The Survey & demarcation of team has been constituted at Bakultala.
- 29-01-2008 - The Range Officer Betapur informed DFO that no Jarawa reserved area is available at Betapur.
- 14-02-2008 - The DFO MA constituted team for Survey & demarcation of Jarawa reserve area at Bakultala.
- 27-02-2008 - The Range Officer Bakultala wrote letter to the Tribal Welfare Officer, Kadamtala to carry out the Survey & demarcation of Jarawa reserve area with the official of AAJVS and revenue along with Forest department.
- 18-03-2008 - The DFO MA wrote letter to the Executive Secretary, AAJVS, Port Blair to issue necessary direction to the Survey team to co-ordinate and complete the work before monsoon.
- 08-08-2008 - Received report on Survey & demarcation of Jarawa reserve area from Range Officer, Bakultala that the surveyed boundary is not yet traced out, hence the revenue survey team may be called to re-survey the area.
