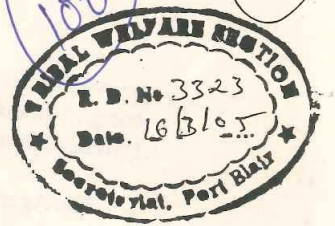

I am directed to state that a provision of Rs 574.38 Crs has been made in the Budget Estimates 2005-2006 under Major Head 2245- Relief on account of Natural Calamities (Non-Plan) to meet the expenditure on relief and payment of compensations on the basis of recommendations of Inter Ministerial Group. In the meantime Government of India, Ministry of Home Affairs as per their letter dated 24th February, 2005 has communicated a total package of Rs 821.88 Crs called "Rajiv Gandhi Rehabilitation package for Tsunami affected areas in Andaman and Nicobar Islands."
