1. NAME OF DEPARTMENT : Electricity
2. NO. & NAME OF SCHEME : 7 - Establishment of 2x24 KW Power House at Little Nicobar.
3. OBJECTIVE OF THE SCHEME :

Establishment of a small power house in the remotest part of the Island the policy of A&N Admn. for providing basic facility and electricity to the tribal population of this island.

It is thus proposed to establish a small power house with 2x24KW DG Set with LT distribution system. This will meet their requirement of power. This scheme has been accorded TEC by CEA vide Letter No.4/10(72)/93/CEA/10 dated 05.05.1993 and Administrative Approval & Expenditure Sanction has been accorded by A&N Administration vide No.11-1(28)/93-Power(DI) dt.12.01.94.
