1. Short title and commencement:

(i) These rules may be called the Andaman & Nicobar Administration (Senior Investigator/Assistant Statistical Officer) Recruitment Rules, 1989.

(ii) They shall come into force on the date of their publication in the official Gezette.

2. Number of posts, Classification and scale of pay:

The number of posts, their classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule annexed hereto.
