No. 55/88/68-158/88 Herr (2)—in exercise of the powers conferred by the provise to article 309 of the Constitution read with the Govt. of India Ministry of Home Affairs Notification 14/3/60ALL dated the 11th April, 1960 the Lieutenant Governor (Administrator). Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the post of CRAFT INSTRUCTOR borne on the establishment of Industrial Training Institute in the Labour Department of Andaman and Nicobar Administration, namely:

1. (1) SHORT TITLE 9 COMMENCEMENT:
These rules may be called the Andaman and Nicobar Administration, (Craft Instructor in the Industrial Training Institute of Labour Department) Recruitment Rules, 1988.

(2) They shall come into force on the date of their publication in the Official Gazette.

NUMBER OF POSTS, THEIR CLASSIFICATION 6 SCALE OF PAY:
The number of the posts, their classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the schedule annexed hereto.

3. METHODS OF RECRUITMENT, AGE-LIMIT 9 OTHER QUALIFICATIONS:
The methods of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in column (5) to (13) of the said schedule.

4. DIS-CUALIFICATIONS: No person—
(a) Who has entered into or contracted a marriage with a person having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for app intment to the said posts;
Provided that the Central Govt, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds or so doing, exempt any person from the operation of this rule.

5. POWER TO RELAX:
Where the Lieutenant Governor (Administrator). Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing and in consultation with the Union Publ

Nothing in those rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for scheduled castes and Scheduled tribes and other special categories of persons in accordance with the orders issued by the Central Govt, from time to time in this regard.
