- i) Matric or its equivalent with mathematics and science as principal subject
 ii) National Trade Certificate or National Apprenticeship Certificate in the respective trade or apprenticeship in an industrial concern for a period of not less than 3 years in the respective trade or persons from reference services having not less than 3 years service in the trade.
 iii) Craft Instructor Certificate from the CTI in the respective trade.

Desirable: Practical experience in the trade concerned.
 OR

Essential :

- (i) Diploma in Engineering/Technology.
 (ii) One year practical experience.

OR
 Craft-Instructor Certificate of the Central Training Institute.
