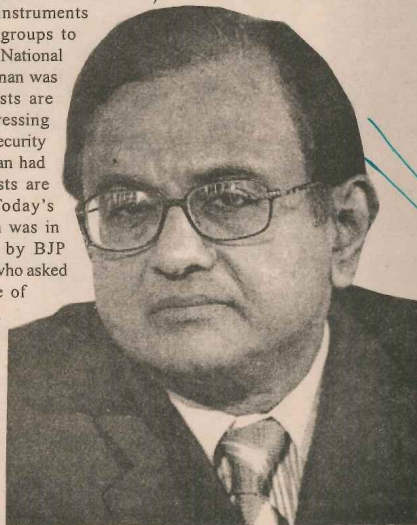
Suspected terror funding being 'closely monitored': FM

New Delhi, Dec 04
Finance Minister Shri P Chidambaram on Tuesday for the first time admitted that the government suspected that terror is being funded using India's stock markets. Speaking in the Rajya Sabha, Shri Chidambaram said, "Recently one case has come to our notice. It is suspected that it may be linked to a person under watch. I cannot divulge further details."

The Finance Minister further added that investigations are on "right now" and the matter is being closely monitored by concerned authorities. By agreeing to the long suspected stock markets terror link, Shri Chidambaram has in a way give out a signal to investors that Indian markets are safe and are closely watched. In fact, the government's position in the matter was clear for some time now, as the SEBI had moved ahead with putting curbs on

Participatory notes (PNs), the instruments suspected to be used by terror groups to invest in Dalal Street. However, National Security Advisor Shri M K Narayanan was the first to suspect that terrorists are investing in stock markets. Addressing the 43rd Munich Conference on Security Policy in February 2007, Narayanan had categorically stated that terrorists are investing in stock markets. Today's comment by Shri Chidambaram was in answer to a pointed question by BJP member Shri Ravi Shankar Prasad who asked whether the government is aware of money being poured into the stock market by terrorist outfits. The share market has witnessed a sharp rise over the last few months with the Sensex touching the 20,000 mark.

The rally has been mainly led by Foreign Institutional Investors (FIIs) who have brought in nearly 68 billion dollars (65.18 billion dollars through equity and 2.7 billion dollars through debt) till November 29, 2007. Commenting on the issue of ban on Participatory Notes, the finance minister said the decision in this regard by the Securities Exchange Board of India (SEBI) was taken on October 25, 2007 in consultation with the government and the Reserve Bank of India



(RBI). He said Participatory Notes have been in vogue for many years. The FII is one of the ways of inflow of funds and there are many other instruments. In October, SEBI had placed restriction on derivatives. There is no absolute ban on PNs, the minister said.
