The former allows money to be transferred from any Western Union outlet in more than 200 countries across the world to Mayabunder within minutes. The recipient can show identification at the post office and quote the money transfer control number to receive upto Rs 50,000/- in cash. This service has already brought in more than Rs 1 cr in the current financial year in the islands through the Port Blair Head Post Office. The eMO service allows money orders to be sent electronically to any of the more than 2500 post offices in the country currently connected online.

Andaman Express is publishing a photograph, which shows that a tourist is touching and feeding biscuits to Jarawa tribes. Though this photographs is easily available in internet since last few month, there is no inquiry in this regards by police or Tribal welfare department.

Sadly, staffs of Police and AAJVS posted around Jarawa Reserve area are either completely untrained or under-trained for a job like protection of Jarawa Tribes from outsiders. There is an old saying Garbage in, Garbage out, and perhaps this is the reason why Jarawa management is hopeless in Jirkatang area.

This is an open secret that most of the tourists visiting Baratang area, are actually those who visit these islands only to see Jarawa primitive tribes. If the Administration is really serious about keeping tourists away from Jarawa then this is high time to restrict tourists from using ATR. As an alternative, tourists could be taken directly to Baratang by an overnight sailing of ferry boats, which will not only save their precious time but also will be convenient for all. This may not be a long shot but its worth trying.

The Jarawa Tribes are already living on borrowed time and if things like Jarwa Tourism continuous for some more years, entire population will be wiped out from these islands very soon.

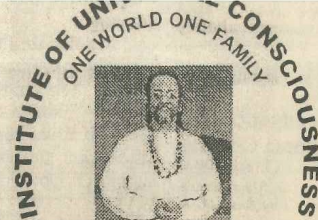
