

As desired by the Secretary (TW) self talked to Mr. A.K. Banerjee Ld. Senior Advocate, Kolkata over phone today regarding the case in CAN No. 060 of 2008, CAN No. 042 of 2008 with MAT No. 016 of 2008 in WP No. 328 of 2007 - Lt. Governor & Ors -Vs- M/S. Barefoot Inns & Leisure Pvt. Ltd. He has informed that he arrived at Calcutta from Germany today and would like to talk on the subject after going through the case tomorrow. He has further desired that a copy of the details of the case may be sent to him for his preparation. As ascertained from Shri. S.K. Mondal, Govt. Pleader the above said Mandamus appeal shall appear in the list under the heading hearing on 10.11.2006 and will come know the exact date of hearing on 10.11.2008 only. The Govt. Pleader was requested to get the date of hearing after a gap of one week or ten days so as to enable us to arrange and to inform Shri. A.K. Banerjee to appear and defend the case at Port Blair.

If approved we may issue the engagement order of Shri. Ashok Kumar Banerjee, Ld. Senior Counsel, Kolkata and also send the following documents for his preparation.

- (4) The Writ Petition filed by M/s Barefoot Inns & Leisure Pvt. Ltd. before the Single Bench of at Hon'ble High Court.
- (5) The judgment dated 17.3.2008 in W.P. No. 328 of 2007 of single Bench of Hon'ble High Court at Calcutta, Circuit Bench at Port Blair.
- (6) The Appeal preferred by Lt./ Governor and three others.
- (7) The interim order(s) issued by the Division Bench in the appeal.
