Missappropriation of Money in the Name fo Lok Adalat

Inaugural Ceremony of 3rd Lok Adalat organised by the State Legal service Authority of A&N Adminis_ tration was held in the High Court annexbuilding on 14. 02. 99. The function was inaugurated by the Lt. Governor Shri I.P. Gupta, Barring the DC, IGP and JS none of the heads of the departments and offices, secretaries, Assistant Secretaries and other gazetted and non gazetted officers of the Admn. was found present in the function. This function was organised with a view to make legal awareness to the public in general · as also to the heads of departments, officers and subordinate to them. When the function started only 20/25 persons including lawyers were found present, it seems to be an insult on the Lt. Governor who chaired the seat as Chief Guest. It seems that invitation cards were not issued to all concerned, who is / are responsible for such callous attitude? It was the concern of legal branch of the Administration.

Secondly huge quantity of sweets packets were shown to have been purchased Purchase of 800 sweets packets for 25 or 50 guests is not logical.

Thirdly, the sitting of the Lok Adalat were held in the court daises of district & sessions judges and Chief Judical Megistrate Murder cases are tried in the Court of Sessions Judges, who is the heads of the judicial authority here. A Panchayat member not having desired education is found sitting on the dais of sessions judge. We, the journalists and Trade Union leaders do have highest respect and regard to that dais. It is really bad that sessions judges chair is occupied by a Panchyat member or illiterate persons or politician, thereby lowering the dignity of chair of a high judicial authority. Lok Adalat could very well be held in the hall whers the inaugural function was held The number of cases disposed of by lok Adalat is less than ten, for which lakhs of rupees is shown to have been debited from public exchequor. We want that the judiciary should be kept above all and our high confidence over it should at no cost be lowered down. Judicial chairs should be occupied only by judges and it should not be shared with any politician or members of Panchyat, Shameful action of the Administration should not be repeated in future.
