Oust Saffron, Save the Republic

In the face of country-wide protests, Thackeray has finally withdrawn his call to disrupt the Indo-Pak cricket series. A few days before, Vajpayee also had to declare that his government was not contemplating any constitutional amendment to ban religious conversion.

This is of course some victory for popular protests but we must not lose sight of the danger which still looms large on the country even as the nation celebrates the 49th Republic day. Thackeray has relented only after his Sainiks held the country to ransom for months on end with absolute impunity. And he has relented only to announce a "temporary suspensism" of his campaign. Worse still, the face saving deal has been brokered by the central government and BJP while the RSS openly supported the Sena's crusade againsr having any cultural or sporting ties with Pakistan

There is a disturbing bet uncanny similarly with the Ayodhya developments in 1991-92. The then central government had brokered similar peace deals with the Sangh Parivar, Narsimha Rao had asked the nation to trust Kalyan Singh, and the laws of the land and history took their own course. The nation and the republic can certainly not live on the edge of small mercies borrowed from the unholy Sena-BJP. nexus.

Meanwhile, aftet intially waxing eloquent against the persecution of Christians, Sonia Gandhi has also started echoing the worn-out saffron theme of Indian secularism being a great Hindu virtue. We have heard this argument so many times from Advani's mouth: "India is secular precisely because it is a Hindu-majority country"!

Nothing could be farther from the truth. Every religion preaches harmony and tolerance, yet there is also a fundamentalist streak in every religion and under favourable historical conditions, it can be expolited to the hilt to articulate the most sectarian and faseist variety of politics. Secularism, as distinct from harmony consists entirely in separation of politics from religion and as such it cannot be the virtue, unique or otherwise of any religion.

We have had all these arguments six years ago. Libereal Hindu opinion certainly does have a role to play against the communal facsim of Hirutva, but diluting and degrading the communist-atheist current of secularism to the liberal Hindu discourse of harmony can only weaken and disorient anticommunal resistance the on whole, Faced with the growing fascist offensive against mincrity communites, our CPI-CPM friends have however once again optep to fall back on the Gandhian plank.

While not rufusing to join hands even with the liberal Hindu school, revolutionary communists will always uphold the real meaning of secularism and remain the most consistent bulwark against communal fascism and for secular democracy. On the eve of the 49th Republic Day, we vow to intensify our resistance against the saffron anti-republican offensive. And our resistance will continue to draw inspiration from the glorious legacy of all who have sned their blood for
