Tribal sub Plan review meeting held in the Chamber of the Assistant Engineer (Elect) , Car Nicobar on 21.10.99 at 4.00 PM.

The meeting was presided over by Shri Chandra Bhushan Kumar, DC (N) and it was attended by the following: -

1. Shri Mohammed Kundani, AE(Elect.), Car Nicobar.
2. Shri P.Mohammed, L.G.C, ITDP.

Moving from the customary way of having Tribal Sub Plan review meeting in the Darbar Hall of the District Office, for the first time we had departmental wise TSP review meeting in the offices of the concerned Sector. The Chairman has asked about the Stock of Diesel, whereupon the AE, has informed that Stock is sufficient for and upto Feb'99.

At the outset, AE, has said that he does not have any records to speak on the progress of the schemes under TSP in respect of other Islands, information pertaining to this may be available with the EE, NRSE, at Port Blair.

The Civil works, ie construction of type I and type II at Car Nicobar is in progress and shall be handed over by APWD, by the end of the current financial year. The AE has raised the requirement of the land at Mus for construction of a transit Diesel Tank at Mus. He has also shown that the Local Contractors of the A.P.W.D, deptt. is collecting sand from the sea shore falling in front of the Rajiv Gandhi Power house, Car Nicobar, causing exposure of underground cables. Whereupon Chairman, ITDP said that this is a serious issue and it will be looked into.

In this connection the Tehsildar, Car Nicobar may call a meeting of Chief Captain, Vice Chief Captain, Car Nicobar, First Captain, Mus and Secretary, Tribal Council, Car Nicobar , EE,ALHW,C/N, EE,CD, APWD, Car Nicobar, 1 st Captain, Malacca, 1st Captain ,Perka, Forest Ranger, TeeTop, Car Nicobar, on a convenient date to discuss the following points :-

1. Requirement of land at Mus especially in view of the proposed jetty at Mus for which necessary administrative approval and financial sanction have been received by the EE, ALHW, Car Nicobar.
2. The issue of sand collection near the power house area or any other matters with the kind permission of the DC(N).
