The P & T, SC/ST Employees, Welfare Association, Delhi, brought to the notice of this Directorate that the representatives of the Assoelation were not being granted any meeting or interview by the Liaison Officers for discussing the problems/grievances of the SC/ST employees. In this connection your attention is invited to the instructions contained in the erstwhile P & T Directorate Circular No. 21-36/37-81/SCT, dated 24-4-1981, on the same subject wherein it was emphasized that SC/ST employees should not be refused interviews by the Liaison Officers. These instructions are still operative and may be adhered to. It is accordingly reiterated that SCIST employees or their representatives may be granted interviews by the Lizison Officers for mitigating former's grievance regarding appointments, promotions, etc. The meetings may, however, be informal without any agenda and no minutes thereof need be prepared.

These orders may please be brought to the notice of Liaison Officers for SC/ST employees for their information and guidance under intimation to this Directorate.

G.I., Dept. of Telecom., Lr. No. 1-13/92-SCT, dated 18/31-8-1992 Subject:—Reservation benefits admissible to SC/ST candidates migrated to the States other than their State of origin.

I am directed to refer to Ministry of Home Affairs Circular No. 35-1/72-RU (SCT), dated 2-5-1975 [Para. 2 (II)], which states that a person migrates from one State to another State, he can claim to belongs to SC/ST only in relation to the State to which he originally belonged and not in respect of States to which he has migrated. This paragraph does not clarify the position in regard to this reservation benefits to be extended to SC/ST in case of Central Government establishments.

2. Many representations have been received in this office for clarifying the status of reservation benefits in the Central Government to those who have migrated to the States other than their State of origin. The clarification in this regard was sought from Ministry of Welfare and from Ministry of Home Affairs (Department of Personnel and Training). It is clarified according to the instructions contained in Letter No. 16014/1/82-SC and BCD-I, dated 6-8-1984 and 22-2-1985, a Scheduled Caste or Scheduled Tribe person on migration from the State of his own engin to another State will not lose his status as SCST, but will be entitled to the concessions/benefits admissible to the SC/ST from the Scale of his origin and not from the State where he has morated.

Subject: Reservation for SC/ST — Filling up of a post by transfer.

It has been brought to the notice of this Department that vacancies reserved for SC/ST are being filled by the appointing authorities by transfer of general category candidates by relaxation of the Recruitment Rules instead of filling them by the prescribed methods of recruitment,

In accordance with provisions of this Department's O.M. No. 36012/67 88-Estt. (SCT), dated 25-4-1989, there is a ban on dereservation of reserved 88-ESH. (SCI), ualed 234-1303, there is a pair of deciseryation of reserved vacancies to be filled by direct recruitment. Vacancies reserved for SC/ST and falling in the direct recruitment quota cannot, therefore, be filled by general category candidates, even by relaxation of the rules. Where general category candidates, even by scrazation of the lines, awarest reserved vacancy is to be filled and the Recruitment Rules do not provide for transfer as a mode of recruitment, it must be filled by an SC/ST candid date even when it is done by transfer by relaxation of the Recruiment Rules. Filling up of such reserved vacancies by general category candidates by resorting to the method of transfer is not permissible.
