

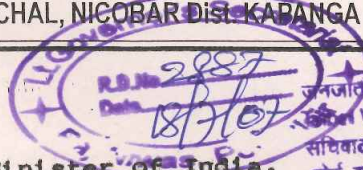

That Sir, We are settled in the Island for Rubber Plantation according to the Indo-cylon Agree ment Sastri Srimao Bandaranayaka Pact of 1964 with the Agreement of Provide Employ- ment in Rubber Plantation Under Rubber Board, Kottayam that time Now the plantation is Governing under the control of the Andaman and Nicobar Islands Forest and Plantation Development Corporation Limited (A Govt. India Undertaking) and We are getting Meagre wages, Which is not sufficient for our daily breads,

The Administration not finalized our allotment of land and resettlement in Non Tribal area, till date, while we to say with painfully that we were already made so many correspondence to the Andaman and Nicobar Administration and Minister level concerned authorities and Ten days Hunger strike which is come to an end by the Advice of Hon'ble Member of Parliament Shri: M.R. Bhakta, and also noted that the Promised to solve our land problem very soon at Press note and meeting at Rajnivas Port Blair held on 7.7.1995 during last visit to these Islands of Hon'ble Home Minister of India.

The Former Hon'ble Prime Minister of India Shri: P.V.Narasimha Rao and the former Hon'ble Home Minister of India Shri: S.B.Chavan also promised to solve our land problem very soon at New Delhi as on 16.11.1995.
